### **DANCE CLASSES TERMS & CONDITIONS**

Thank you for choosing Jimmy Hellas Dance Services for your dance education. Please take a moment to read through the Terms and Conditions.

### **1. GENERAL CONDITIONS**

**1.1** All classes for **Greek Dance**, **Belly Dance**, **Ballroom Dance** (whether **Group** or **Private** or **Workshops**) are for **adults (16+)** and **kids (7-15)**.

1.2 All classes must be booked **prior** to the date and time they are about to run.

**1.3** Jimmy or the Workshop organiser reserves the right to choose and decide the dance styles conducted at **Group Dance Classes** and special workshops. Where the class is private, you may request to be taught any specific dance style(s).

**1.4** Where classes are held in a dance studio, the dance studio facilities must be kept neat and tidy at all times. For further information read the <u>Studio Terms & Conditions</u>.

**1.5** Where classes are held in private residential homes or in commercial properties, it is the owner(s) responsibility to ensure:

**1.5.1** Adequate dance space is available, **i.e.** approximately **3m<sup>2</sup> per person**.

**1.5.2** Furniture is removed or moved to the back of a room and away from participants.

**1.5.3** The room is installed with hardwood or veneer floors. A class cannot run if there is carpet or tiles.

**1.5.4** The owner(s) (or organizer(s)) are responsible for cleaning up after all participants, **i.e.** drinking glasses, cups, food, etc.

**1.6** Extensions will not be granted if you miss any class. Missed classes are non-refundable and cannot be carried forward.

**1.7** Every class starts and ends on time and there will be no extensions or refunds if any participants are late.

**1.7.1** If Jimmy runs late and is unable to start the class on time, he will make up for lost time either during the day of the class or at the next running class. If this is impossible students will be refunded.

**1.7.2** If you are late for your dance class, the class can still go ahead. There will be no refunds or extensions for your lost time and the class will end as per the agreed finish time. There may be occasions where the class can be extended on the day, but this is not always a possibility or guarantee.

**1.8** Students are strictly prohibited from video recording any dance classes.

### 2. PAYMENT (Price List)

**2.1** Bookings must be made online and in advance for all classes. There will be no holds or **IOUs** given. Jimmy will not accept **cash in hand** payments.

**2.2** Payment of all kind classes is required to be paid the latest **24 hours** in advance to the agreed date and time of each class.

#### **3. CANCELLATIONS**

**3.1** If you cancel or reschedule **less than 48 hours** prior to the agreed date and time of your private class, this will be considered as a missed class and there will be no extensions or refunds.

**3.2** If you cancel or reschedule **more than 24 hours** prior to the agreed date and time of your private class, you will receive a refund, however a **\$30 studio fee** is deducted from the balance of your refund.

**3.3 Unattended group dance classes** considered as lost and not refundable. Group dance classes cannot be canceled or rescheduled.

**3.4** If Jimmy cancels a class **24 hours before** the class is due to commence, you have the option to:

**3.4.1** Attend the next available class that suits you and you will not be charged any additional fees; or

**3.4.2** Request a refund. A refund will be issued **within 24 hours**. Receiving the refunded amount back into your bank account can take **up to 3-5 business days**, subject to your banking institution.

**3.5** If Jimmy cancels a class (whether **Private** or **Group**) on the day a class is scheduled, and you have already paid and arrived at the dance studio, you have the option to:

**3.5.1** Jimmy will refund you back for this particular class (whether **Private** or **Group**) and you will receive **1 more class** for free as a compensation. A refunded will be issued **within 24 hours**. Receiving the refunded amount back into your bank account can take **up to 3-5 business days**, subject to the conditions of your banking institution.

### 4. CHOREOGRAPHY CLASSES

**4.1** All choreographies produced and taught by Jimmy are the **sole copyright ownership of Jimmy** and cannot be performed without his consent and approval. Choreographies cannot be reproduced or taught by any other persons or to any other persons without Jimmy's written consent and approval.

**4.2** Some choreography classes may be video recorded by Jimmy in order to be protected under copyright laws.

**4.3** Students who perform choreographies must perform them only on the date; at the event and venue intended and strictly prohibited to perform the choreographies for any other purposes without Jimmy's written consent and approval.
